MARK YOUR CALENDARS

August 4 will be a Work Day at the Hall. The work crew will remove the rest of the Annex siding and install new windows. If the forecast is for temperatures over 90, the workday will be postponed until August 11.

On Monday, August 17, at 6:00 PM Bob Luff, Talbot County's RACES & ARES Radio Officer, will present a briefing at the Hall on using inexpensive Family Radio Service radios to establish a backup Village Emergency Radio Network. Bob, along with CERTs (Citizen Emergency Response Teams) and local Amateur Radio Operators have already partnered in starting such a network in Wittman. This network enables individual village people/ families to stay in touch during emergencies when electrical power, telephone, cell phone services may be disrupted. Talbot amateur radio operators can monitor and relay emergency calls to the County's Emergency Management Center (EOC) using their more powerful transmitters and the established RACEs & ARES Emergency Over-the-Air Networks staffed at the EOC. As the Wittman trial is showing, it is possible for a village to quickly and inexpensively establish a Village Network that will support comforting and emergency situation communications that is completely independent from relying on power, telephone, or cell service. The partnership with the Amateur Radio community means reliable emergency communications to the 911/ EOC or beyond as necessary.

PROPOSED BYLAWS CHANGE

Proposed Amendment to Claiborne Association Bylaws:

Prior to issuing a Tax Exempt Card to any non-profit corporation, the State of Maryland requires the organization's Bylaws to include a section describing the organization's process for distributing its assets should it cease to function. The proposed change would enable the Claiborne Association to choose one or more organizations, such as the Mid-Shore Community Foundation or the Bay Hundred Foundation, to receive its assets. The change would appear in Article I. A new Section 5 would be added and the current Section 5 would become Section 6.



Changing the Bylaws requires presenting a proposed amendment at a General Meeting, discussing the motion, and tabling it until the next General Meeting where it would be presented for a vote. This proposal will be presented for a vote in December 2015.

The proposed language is:

Section 5:

Adjourn


"<u>Distribution Upon Dissolution</u>: Upon termination or dissolution of the Claiborne Association, any assets lawfully available for distribution shall be distributed to one or more qualifying



organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the Association. The organization to receive the assets shall be chosen by a majority vote of the membership of the Association."

CLAIBORNE HALL UPDATE





The Board has selected a layout for the future kitchen and bath. This decision enabled the selection of window sizes and locations. The Board also decided that the disabled access ramp should enter the Annex through the second window opening along the northwest side. The door for that opening was ordered along with the windows. The windows and door arrived this week.

The Board has applied for a \$6,000 grant from Christmas in St Michaels to provide half of the funding for a new bathroom. The funding would be used to purchase and install a septic holding tank, install the plumbing needed for the bath and a kitchen and to tie into the village water supply. The other half of the cost will consist of donated labor and materials. The Kuperberg family has generously volunteered to donate fixtures for the accessible bathroom. We also have a grant request pending with the Mid Shore Community Foundation to fund new insulation for the Hall.



Next steps toward completing the Annex renovation include getting a structural engineer's report so we can apply for a use permit and developing a coherent written plan so we can apply for the required building and health permits.
